Jeff Jordan was a 4X Ohio State Champion, Big Ten Champion and 2X All-American at the University of Wisconsin. Coach Jordan spent 5 years coaching at Purdue University before moving back to his hometown in Ohio. ***Coach Jordan has since led St. Paris Graham High School to 13 straight Div. II State Championships as well as 2 National Championships during that time.*** He has been named National Coach of the Year on two occasions. Coach Jordan has coached many wrestlers that have gone on to become NCAA All-Americans, including current Penn State wrestler and defending National Champion David Taylor.
